Subject: Selection of Senior Residents departments of _____ Govt Medical College Handwara on Academic Arrangement Basis as per S.O 364 of 2020, dated:27/11/2020.

Whereas, The Government Medical College, Handwara, advertised vacant positions of Senior Residents and Tutors in various departments through **Advertisement Notification No. 02 (SR) of 2025, Dt: 05/02/2025** purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated:27-11-2020.

Whereas, in continuation of **Office Order No. 07- SR(GMCH) of 2025, dated 05-03-2025**, regarding the selection of Senior Residents/Tutors in various departments of Government Medical College Handwara a written MCQ-Based test was conducted for the departments annexed in Annexure I of the given office order as per Criteria/Policy guidelines for eligibility and selection to tenured positions, as specified in **Govt Order No. 383-JK(HME) of 2024, Dt:20/06/2024**.

Whereas, the result of marks obtained in MCQ-based (OMR) written test by all the candidates for the different departments is attached as **Annexure I** to this notification.

Whereas, the tie in marks for candidates in the Department of Anaesthesiology was resolved based on the age criteria as per the JKPSB Business and Procedure Rules of 2021, dated 05/04/2021, since both candidates possess identical qualifications.

Therefore, based on the marks obtained in the MCQ-based (OMR) written test and vacancies available in all the departments, candidates listed in **Annexure II** of this notification are hereby provisionally **selected** for the tenured positions in the respective departments as indicated against their names. The waiting list of candidates for each department is attached as **Annexure III**, which shall be valid for 03 months, in case of failure of candidate to join, or in case candidate leaves the tenured position midway, the next candidate in the merit list will be invited to join.

However, as per the advertisement and rules of engagement, the candidates are provisionally selected on academic arrangement basis initially for a period of **01 year** which can be extended to a maximum of 03 years based on performance and good conduct report by the concerned head of the department/section.

However, engagement of the selected doctors shall be subject to the following conditions:

1. That the doctors shall submit their *joining report* along with all the original documents for verification in the office of Principal Govt Medical College Handwara within **10 days** from the date of issuance of this selection order.

- a. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - b. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - c. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
 - d. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - e. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
 - f. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
2. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment of 01 year
 3. Candidates who results are awaited at the time of selection must submit an affidavit/undertaking duly attested by first class magistrate stating that they will provide the degree and registration certificates within one of joining. Failure to do so will lead to cancellation of candidature and selection ab-initio.
 4. Salary will be disbursed only after the proper CID Verification of the candidates.
 5. No experience certificate will be issued if he/she leaves fails to serve his/her tenured position for at least 06 months.
