Whereas, The Government Medical College, Handwara, advertised vacant positions of Senior Residents and Tutors in various departments through **Advertisement Notification No. 05 (SR) of 2025, Dt: 14-12-2024** purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated:27-11-2020.

Whereas, in continuation of **Office Order No. 05- SR(GMCH) of 2025, dated 21-02-2025**, regarding the selection of Senior Residents in the Department of Pathology and Anatomy of Government Medical College Handwara a provisional selection and waiting list was annexed as *Annexure II* in the given the office order.

Whereas, among the candidate selected, in the selection list annexed in Office Order No. 05- SR(GMCH) of 2025, dated 21-02-2025, only 02 joined in the stipulated time period which ended on 12-03-2025 for the department of Pathology.

Henceforth based on vacancy available and as per rules envisaged in Government Order No. 382-JK(HME) of 2024, dated 20-06-2024 and upon operationalization of waiting list, **01** candidate mentioned in waiting list (as annexed in Annexure III of Office Order No. 05- SR(GMCH) of 2025, dated 21-02-2025) namely **Dr lyman Rasool Lone (MD-Pathology)** is selected for the post of Senior Resident in department of Pathology of Govt. Medical College, Handwara on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

However, engagement of the selected doctor shall be subject to the following conditions:

1. That the doctors shall submit their joining report in the office of Principal Govt Medical College Handwara within **10 days** from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - i. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - ii. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.

- III. He/she shall not leave the department before the completion of his/her sanctioned tenure.
 - IV. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
 - V. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment of 01 Year.
 4. Salary will be disbursed only after the proper CID Verification of the candidates.
 5. No experience certificate will be issued if he/she leaves fails to serve his/her tenured position for at least 06 months.
