Subject: Interview notice for the various categories of posts under Addiction Treatement Facility (ATF) of GMC Handwara notified vide advertisement notification no. 06 of 2024 dated 01/01/2024.

### NOTICE DATED: 19-07-2024.

The Govt Medical College Handwara advertised various categories of posts under Addiction Treatment Facility (ATF) sponsored by National Drug Dependence Treatment Center (NDDTC) AIIMS New Dehli on contract basis vide advertised notification No. of 06 of 2024 dated 01-01-24 for a period of one year extendable on yearly basis subject to good performance and conduct or till the continuation of centrally sponsored scheme, which ever is earlier.

Whereas, Govt Medical College Handwara received total of 718 applications out of which only 432 applications were submitted with required fee till last date of submission.

Whereas screening committee was constituted vide order no. GMC/HAND/2024/1166-68 dated 13/01/2024 for screening of online applications. After screening of all applications only 432 applicants were found to be eligible for written examination.

Whereas, Govt Medical College Handwara conducted the OMR based written examination for these categories of posts vide advertised notification No. of 06 of 2024 dated 01-01-24.

Whereas, out of 432 applicants only 211 applicants appeared in written examination, as 06 for Medical Officer post, 39 for counsellor post, 69 for data manager post and 97 for nurse post.

Whereas, Govt Medical College Handwara notified Revised/Final answer key vide notification no GMC/Hand/2024/14 dated 08-04-2024, inrespect of the aforesaid posts and the same was uploaded on the official website of GMC Handwara for the information of candidates.

Accordingly on the basis of OMR written test and Academic merit, the name of candidates mentioned in Annexure-A to this notification are shortlisted for interview / Viva Voce examination.

#### NOTE:

- 1. The interview will be held in GMC Handwara on 24-07 -2024 at 11.00 AM
- 2. The candidates shall produce their original certificates/testimonials along with the hard copy of application forms on the date of interview.
- 3. The candidature of all the candidates is purely provisional. The documents of the candidates will be verified at the time of interview. In case of any discrepancy with regard to the academic merit and other eligibility conditions is noticed at the time of interview or, thereafter, the candidates shall not be allowed to appear in the interview, the candidature shall be deemed to have been cancelled in ab-initio.
