Whereas, Government Medical College, Handwara advertised for vacant posts of Junior Residents in various departments against available vacancies vide **Advertisement Notice No. 01-JR (GMCH) of 2025, Dated: 13-01-2025** purely on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

Whereas, in continuation to **Notice No. PS/GMCH/2024/885-86, Dated:20-01-2025** and based on the number of application forms received, Government Medical College Handwara conducted Multiple Choice Question (MCQ) OMR Based Test on 12th February 2025, notified vide notification No: **GMC/Hand/2025/Acad/55-57, Dated: 04-02-2025.**

Whereas, the provisional selection list, based on the marks obtained and availability of vacancies, was issued vide **Office Order No. 06-JR(GMCH) of 2025 Dated: 27-02-2025.**, wherein candidates listed in **Annexure II** were provisionally selected for the posts of Junior Residents in various departments, and a waiting list was annexed as **Annexure III.**

Whereas, the last date for joining for the provisionally selected candidates (**Annexure II**) was stipulated as 05-03-2025 (07 days from the date of notification). Out of the **29** selected candidates, **25** joined within the stipulated time, while **04** candidates failed to report.

Now, therefore, in light of the vacancies arising due to failure of joining, and resignations tendered the waiting list is hereby operationalized. The candidates mentioned in "**Annexure I**" of this notification are hereby selected for the posts of Junior Residents in various departments of Government Medical College Handwara on Academic Arrangement Basis under S.O 364 of 2020, dated 27-11-2020.

The engagement of the selected candidates is strictly provisional and initially for a period of six (06) months, which may be extended up to one year subject to performance and good conduct, as reported by the concerned Head of Department/Section. 1. **Joining and Document Verification:** Candidates must submit a joining report along with all original documents for verification at the Principal's Office, Government Medical College, Handwara, within Seven (07) days of the date of this order. Failure to comply will result in the cancellation of the candidate's appointment
2. **Affidavit Submission:** Each candidate shall submit an affidavit, attested by a First-Class Magistrate, affirming:
 - i. Non-involvement in any criminal activity or pending FIR.
 - ii. Commitment to refrain from private practice during the tenure, with immediate termination upon any violation.
 - iii. Commitment to complete the sanctioned tenure without resignation.
 - iv. Agreement not to participate in any form of strike, as services are governed by the Essential Services Maintenance Act (ESMA).
 - v. Adherence to professional conduct standards, with termination of service for any misconduct.
3. **Security Deposit:** The first month's salary shall be held in deposit by the Accounts Department as security, to be released upon successful completion of the initial tenure of 06 months.
4. **CID Verification:** Salary disbursement is contingent upon satisfactory CID verification.
5. No experience certificate will be issued if he/she leaves without completing his/her sanctioned tenure
