Sub: Selection of Junior Residents in various departments of Govt Medical College Handwara on Academic Arrangement Basis as per S.O 364 of 2020, dated:27/11/2020.

Whereas, Government Medical College, Handwara advertised for vacant posts of Junior Residents in various departments against available vacancies vide Advt. Notification No. **04 of 2023 Dated:14-11-2022** purely on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

Whereas, a selection committee was constituted by the Principal Govt Medical College Handwara vide order No. **GMC/Hand/2023/Acad/881-885, Dated: 01/12/2023** for scrutinizing of applications forms and documents of all the candidates.

Whereas; all the candidates were called for the interview on **11/12/2023** vide notification no. **GMC/Hand/2023/Acad/897-902, Dated: 05/12/2023.** The interview was conducted as per schedule and the candidates appeared in front of the selection committee for viva voce and document verification was also carried out on the same day.

Pursuant to the recommendations of Junior Resident Selection committee, the candidates enlisted in **Annexure I** to this notification are hereby provisionally selected for the post of Junior Residents in various departments, mentioned against each name, of Govt Medical College Handwara.

However, as per the advertisement and rules of engagement, the candidates are provisionally selected on academic arrangement basis initially for a period of **06 months** which can be extended to a maximum of 01 year based on performance and good conduct report by the concerned head of the department/section.

However, engagement of the selected doctors shall be subject to the following conditions:

1. That the doctors shall submit their joining report in the office of Principal Govt Medical College Handwara within **10 days** from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
 - I. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
 - II. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his/her appointment shall be terminated without any notice.
 - III. He/She shall not leave the department before the completion of his/her sanctioned tenure.
 - IV. He/She will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.


