Subject:- Provisional Selection list IV in terms of operation of waiting list in addition to notification No. 68-GMCH of 2024 dated 09-11-2024 of Para-medical staff in Various Departments of Government Medical College, Handwara on Academic Arrangement basis as per S.0 364 of 2020, dated:27/11/2020 advertised vide No. 03 of 2023 dated 15.04.2023.

> Notification No. 114 -GMCH of 2025. Dated: 23 -01-2025.

Whereas, the Government Medical College, Handwara, advertised 50 posts of Jr. Staff Nurse and 09 posts of Technical Lab Assistants at Sr. No. 10 and Sr. No. 2 respectively Vide Advertisement Notification No. 03 of 2023, Dated 15-04-2023, on Academic Arrangement basis initially for a period of one year extendable up to maximum of six years (subject to good performance and conduct) or till the selection is made in accordance with the recruitment rules whichever is earlier as per S.O. 364 of 2020, Dated: 27-11-2020 and other applicable rules issued on the subject from time to time by the Government; and

Whereas, the aforesaid advertisement notification prescribed the qualification, terms and conditions for making engagement against the said posts; and

Whereas, vide Notification No. GMCH/Acctts/01 of 2024 dated 26/07/2024, the MCQ-based written test was conducted for various posts except for the posts of Technical Assistant and the Technician for the Animal Operation Room w.e.f 30th July 2024 through University of Kashmir at Hazratbal Campus, Srinagar; and

Whereas, the representations received from the candidates after issuing written test/examination notice for the posts of Lab Technician, Technical lab Assistant, Technical Theatre Assistant, Audiometry Technician, Speech Therapist, Radiographic Technician, Physiotherapist, Clinical Psychologist, Jr. Staff Nurse and Pharmacist on Academic Arrangement Basis

posts for Govt Medical College Handwara were considered and disposed of vide No. PS/GMCH/761-63 dated 29-07-2024; and

Whereas, the marks obtained by the candidates/score of the candidates in the MCQ-based (OMR) written test were notified vide notification No. 56-GMCH of 2024 dated 14.10.2024 wherein two days were provided for objections, if any; and

Whereas, in response to the aforesaid notification, the Govt. Medical College Handwara received various representations from candidates within the stipulated time wherein the issues raised have been addressed; and

Whereas, in view of the above representations received notification No. 56-GMCH of 2024 dated 14-10-2024 was kept in abeyance vide notification No. 57-GMCH of 2024 dated 15.10.2024 with the direction to the candidates to produce their category/reservation certificates within three days from the date of notification; and

Whereas, the aforesaid representations were considered and disposed of by the selection committee for para-medical posts(Academic arrangement) of Government Medical College Handwara vide Notification No. 67-GMCH of 2024 dated 09-11-2024; and

Whereas, provisional selection lists and provisional waiting lists were published vide notification dated 09-11-2024, notification dated 03-12-2024 and notification dated 04-01-2025; and

Whereas, it was provided in the aforementioned notifications that the selection is provisional and objections if any shall be submitted to principal GMC Handwara within two days for examination and disposal. No claim shall be entertained after 2 days from the date of issuance of this notification; and

Whereas, representations were received and were considered and disposed of by the selection committee and subsequently supplementary provisional selection list and the provisional selection list II, provisional selection list III were issued against the vacancies caused due to non-joining of the selected candidates and lack of the requisite documents etc vide

notification No. 74-GMCH of 2024 dated 03-12-2024, vide notification No. 75-GMCH of 2024 dated 03-12-2024 and notification No. 104-GMCH of 2025 dated 04-01-2025 respectively; and

Whereas, in response to the Provisional Selection list III dated 04-01-2025 vacancies have been caused due to non-joining of the candidates and other reasons; and

Whereas, the committee decided to issue provisional selection list IV in continuation to Notification No. 68-GMCH of 2024 dated 09-11-2024 strictly in accordance with the applicable Reservation act and rules thereof.

**Now therefore,** the waiting list is operated for the vacancies caused in order of merit secured by the candidates in OMR Based written examination and the sequence in terms of applicable reservation roaster. Accordingly, provisional selection list IV is issued as **Annexure-I** to this notification and the provisional waiting list is issued as **Annexure-II** to this notification, in continuation to Notification No. 68-GMCH of 2024 dated 09-11-2024.

The provisional selection list IV shall be subject to the outcome of any writ petition(s), or any other petition/application pending in any court of law/Tribunal of competent jurisdiction.

**However,** as per the advertisement and rules of engagement, the candidates are provisionally selected on academic arrangement basis initially for a period of 01 year which can be extended to a maximum of 06 years based on performance and good conduct, the engagement of the selected candidates shall be subject to the following conditions: -

- That the provisionally selected candidates shall submit their joining report along with original documents in the office of Principal Government Medical College Handwara within 10 days w.e.f 23-01-2025.
- That the acceptance of joining report is subject to the production of original documents regarding qualification, category if any, domicile certificate, ID proof, DOB certificate and Registration Certificate.

That the candidates shall submit an affidavit duly attested by first class magistrate to the effect that:

He/she is not involved in any subversive activity and there is no FIR pending against him in any Criminal Department or Police Station, dismissed from service or discharged from service on the

He/she will not participate in any kind of strike during the period II.

He/she shall remain disciplined during the contract period and any kind of misconduct shall make him/her liable for termination III. without any prior notice.

That he/she shall not have any claim for engagement in case the documents produced are proved to be forged, fabricated or IV. fraudulent and the engagement shall be deemed cancelled abintio.

4. Salary will be disbursed only after the proper CID Verification of the candidates and document verification.

5. If any discrepancy is found in the documents the candidature shall be cancelled/rejected ab-intio and the candidate shall have no claim for engagement.

6. No experience certificate will be issued if he/she leaves/ fails to serve his/her first contract position for at least 06 months.

7. The selection is provisional and objections if any shall be submitted to principal GMC Handwara within two days for examination and disposal. No claim shall be entertained after 2 days from the date of issuance of this notification.

8. The engagement is initially for one year extendable up to 6 years subject to good performance and conduct or till selection/promotion is made in accordance with rules of recruitment governing the respective posts, whichever is earlier. The extension so granted shall not be beyond a period of 6 years under any circumstances.

9. The selection shall be purely on academic arrangement basis only, without conferment of any preferential right on the selectees for regular
