Selection for Various Non-Gazetted (Technical) Staff Posts in various departments of Govt Medical College Handwara on Academic Arrangement Basis as per S.O 364 of 2020, dated:27/11/2020.

ORDER NO. 18 -NG (GMCH) of 2026

Whereas, Government Medical College, Handwara advertised various Non-Gazetted (Technical) Staff posts in various departments against available vacancies vide Advertisement Notice No. 05-NG (GMCH) of 2025, Dated 24-04-2025, purely on Academic Arrangement Basis as per S.O. 364 dated 27-11-2020; and

Whereas, Government Medical College, Handwara conducted a Multiple-Choice Question (MCQ) OMR-based written test for the above-mentioned posts on 3rd February, 2026, as notified vide Notification No. GMC/Hand/2026/Acad/60-62, Dated 22-01-2026; and

Whereas, for the post of Theatre Technician, out of 57 eligible candidates, 49 appeared (08 being absent), and the result/score sheet of marks obtained in the OMR-based test was published vide order No. 03-NG(GMCH) of 2026 dated 24-02-2026; and

Whereas, a representation was received from a candidate namely *Sanam Kumar Baghat* stating therein that he has appeared in written examination for the post of Theatre Technician under the Scheduled Caste(SC) category and as per advertisement notification there was one post reserved for SC category and the applicant stated that he has scored 68.50 marks under Roll No. 2620042 and requested for positive response in the matter; and

Whereas, after receiving the representation the application form of the candidate was scrutinized and it has been found that the candidate has applied under SC category but during data entry by Data Entry Operators the category of applicant was recorded as OM instead of SC due to oversight/typographical error; and

Whereas, the Provisional Selection List has not been issued in respect of SC category as there was no eligible candidate available under the said category. However, after considering the representation and verification of records it has been found that the candidate namely **Sanam Kumar Baghat** has applied under SC category and is eligible for consideration under the said category against the vacant post of *Theatre Technician*.

Therefore, based on the marks obtained in the written test and against the vacancy available, the candidate namely **Sanam Kumar Baghat** bearing Roll No. **2620042** has secured **68.25 Marks** and is the only eligible/meritorious candidate under **SC category** and is hereby provisionally engaged against the post of Theatre Technician under SC category advertised vide Notification No. 05-NG(GMCH) of 2025 dated 24.04.2025 in Government Medical College, Handwara.

However, as per the terms and conditions of the advertisement and rules governing the engagement, the selected candidate shall be engaged on Academic Arrangement Basis initially for a period of 01 Year, extendable up to a maximum of 06 years, subject to satisfactory performance and good conduct report from the concerned Head of the Department/Section.

However, engagement of the selected candidate shall be subject to the following conditions:

- 1. Joining and Document Verification:** Candidate must submit a joining report along with all original documents for verification at the Principal's Office, Government Medical College, Handwara, within Ten (10) days from the date of issuance of this order. Failure to comply will result in the cancellation of the candidate's engagement.
- 2. Affidavit Submission:** The candidate shall submit an affidavit, attested by a First-Class Judicial Magistrate, affirming:
 - i.** Non-involvement in any criminal activity or pending FIR or enquiry in any offence.
 - ii.** Undertake to refrain from private practice during the tenure, with immediate termination upon any violation.
 - iii.** Undertake to complete the sanctioned tenure without

resignation.

- iv. Agreement not to participate in any form of strike, as services are governed by the Essential Services Maintenance Act (ESMA).
- v. Adherence to professional conduct standards, with termination of service for any misconduct.
- vi. That they shall not leave the institution before completion of the one-year engagement period.

3. **CID Verification:** Salary disbursement is contingent upon satisfactory CID verification.
4. No work certificate will be issued if he/she leaves without completing his/her first sanctioned tenure.
5. The engagement shall be purely on Academic Arrangement basis and shall not confer any right whatsoever for regular appointment or continuation beyond the engagement period
6. The academic arrangement shall cease automatically on joining of regularly selected candidates by the competent authority.

- In case candidates are selected through a single selection order, the candidate with lower merit shall be disengaged first.
- In case candidates are selected through different selection orders, the candidate selected earlier in point of time shall be disengaged first.
