1. Before joining the department, the selectee shall submit an affidavit duly attested by the judicial magistrate in the office of the Principal Govt Medical College, Handwara to the effect that: -

- A. He/she will not participate in any kind of strike during the period of his/ her tenure engagement. In the event, he/she proceeded on strike, hi/her tenure engagement shall be terminated without any notice as this service is covered under ESMA act.
 - B. He/ She shall remain disciplined during the tenure period, any kind of misconduct makes him/her liable for termination without any prior notice.
 - C. He/she is not involved in any criminal activity or there is no FIR pending or registered in any criminal or police station against his/her.
 - D. He/ She shall not claim any experience certificate in case he/she leaves senior residency before completion of one year.
 - E. He/she will not indulge himself/herself in any private practice. In case he /she is found doing private practice his/ her appointment shall be terminated without any notice.
 - F. He/she is a non- PSC candidate and in case of PSC candidate he/she shall submit NOC from the competent authority.
2. The appointee is required to join within (15) days from the date of issuance of this order falling which the order shall be deemed to have cancelled. The selected candidate is supposed to submit the joining report in the office of the Principal GMC Handwara before he/ she will be directed to report to the concerned department.
 3. The first month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
