Sub: Operationalization of Waiting List and Thereof Selection of of Junior Residents in various departments of Govt Medical College Handwara on Academic Arrangement Basis as per S.O 364 of 2020, dated:27/11/2020.

Whereas, Government Medical College, Handwara advertised for vacant posts of Junior Residents in various departments against available vacancies vide **Advertisement Notice No. 04-JR of 2024, dated: 21-06-2024** purely on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

Whereas, based on the number of application forms received, Government Medical College Handwara conducted Multiple Choice Question (MCQ) OMR Based Test on 19th October 2024, notified vide notification No: **GMC/Hand/2024/Acad/611-13 Dated: 15/10/2024.**

Whereas, the provisional selection list, based on the marks obtained and availability of vacancies, was issued vide **Office Order No. 37-GMCH of 2024, dated 19-11-2024**, wherein candidates listed in **Annexure II** were provisionally selected for the posts of Junior Residents in various departments, and a waiting list was annexed as **Annexure III.**

Whereas, the last date for joining for the provisionally selected candidates (**Annexure II**) was stipulated as 29-11-2024 (10 days from the date of notification). Out of the selected candidates, **17** joined within the stipulated time, while **08** candidates failed to report.

Now, therefore, in light of the vacancies arising due to failure of joining, resignations tendered, and completion of the one-year tenure, the waiting list is hereby operationalized. The candidates mentioned in "**Annexure I**" of this notification are hereby selected for the posts of Junior Residents in various departments of Government Medical College Handwara on Academic Arrangement Basis under S.O 364 of 2020, dated 27-11-2020.

The engagement of the selected candidates is strictly provisional and initially for a period of six (06) months, which may be extended up to one year subject to performance and good conduct, as reported by the concerned Head of Department/Section. However, engagement of the selected doctors shall be subject to the following conditions:

1. The candidates shall submit their Joining Report along with Original Documents for verification in the office of the Principal, GMC Handwara, within 10 days from the date of issuance of this order. Failure to join within the stipulated time shall result in cancellation of the candidature.
2. The candidates shall furnish an **affidavit duly attested by a First-Class Magistrate** declaring the following:
 - i. That he/she is not involved in any criminal activity and that no FIR is pending against him/her in any police station or criminal department.
 - ii. That he/she shall not indulge in private practice during the tenure. Any violation of this condition shall result in termination of the appointment without any prior notice.
 - iii. That he/she shall not resign or leave the department before the completion of the sanctioned tenure.
 - iv. That he/she shall not participate in any strike or similar activities during the tenure, as the services fall under the purview of the Essential Services Maintenance Act (ESMA).
 - v. That he/she shall maintain discipline and good conduct during the tenure. Any misconduct shall render him/her liable for immediate termination without notice.
 - vi. That he/she is not on the rolls of any other medical college or institution in any capacity.
3. The first month's salary of the candidate shall remain in deposit with the Accounts Section as security and shall only be released upon successful completion of the initial six-month tenure.
4. Salary disbursement shall be subject to verification of character and antecedents through proper CID verification.
5. No experience certificate shall be issued to any candidate leaving the department before the completion of the sanctioned tenure
