### OFFICE ORDER NO. 32 GMCH of 2024

**SUB: OPERATIONALIZATION OF WAITING LIST AND SELECTION THEREOF OF SENIOR RESIDENTS FOR THE VACANT POSTS ON ACADEMIC ARRANGEMENT BASIS AS PER S.O. 364 OF 27-11-2020 DATED: 27-11-2020 IN GOVT. MEDICAL COLLEGE, HANDWARA.**

Whereas, The Government Medical College, Handwara, advertised vacant positions of Senior Residents and Tutors in various departments through *Advertisement Notification No. 03 of 2024, Dt: 12-06-2024* purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated:27-11-2020.

Whereas, in continuation of *Office Order No. 29 of 2024, Dated: 03-07-2024*, regarding the selection of Senior Residents/Tutors in various departments of Government Medical College Handwara, the MCQ-based (OMR) written test mandated by *Government Order No. 382-JK(HME) of 2024, dated 20-06-2024*, for the eligible candidates for departments of Otorhinolaryngology (ENT), Orthopaedics, Obstetrics and Gynaecology, Paediatrics, and Microbiology was conducted on 24-07-2024 notified vide notification No: GMC/Hand/2024/Acad/335-37, Dated: 16/07/2024.

Whereas, the based-on result of marks obtained in MCQ-based (OMR) written test the selection list was delineated as *Annexure II of Office Order No. 27-GMCH of 2024. Dated: 05-08-2024*. Also a total of 12 candidates were delineated in *Annexure III* as waiting list of for each department in the given order.

Whereas, the last date of joining for the candidates annexed in *Annexure I* of Office Order No. 27-GMCH of 2024 Dated:05-08-2024 (Final Selection list) was 15-08-2024 (10 days from the day of notification of selection). Consequently, a total of 07 candidates joined in various departments within the stipulated time frame and 05 candidates (01 in Obstetrics & Gynaecology, 02 in Microbiology and 02 in Paediatrics) failed to join. Also, 01 candidate (Obstetrics & Gynaecology) resigned within 02 days of joining and resignation was accepted.

Henceforth based on vacancies available and operationalization of waiting list, 03 candidates mentioned in *Annexure IV* of this notification are selected for the posts of Senior Residents in various departments of Govt. Medical College, Handwara on Academic Arrangement basis as per S.O 364 dated 27-11-2020.

However, engagement of the selected doctors shall be subject to the following conditions:

1. That the doctors shall submit their joining report in the office of Principal Govt Medical College Handwara within **10 days** from the date of issuance of this selection order.
2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:
  - I. He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
  - II. He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
  - III. He/she shall not leave the department before the completion of his/her sanctioned tenure.
  - IV. He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
  - V. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
3. First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment.
4. Salary will be disbursed only after the proper CID Verification of the candidates.
5. No experience certificate will be issued if he/she leaves fails to serve his/her first tenured position for at least 06 months.
