#### NOTIFICATION.

The admission process for 1st MBBS batch for academic session 2024-25, will be starting from 24-08-2024 after first round of Counselling for All India Quota (Allotment Process) for NEET-UG (MBBS/BDS/BSC Nursing) and will follow the schedule as prescribed in the notification.

The prescribed format of application form to be submitted at the time of admission is herewith attached as *Annexure I* for State Quota candidates (85%) and as *Annexure II* for All India Quota candidates (15%)

The document checklist attached as Annexure III is to be submitted in Original and Xerox at the time of admission. The candidates/parents are also required to submit the affidavits in the prescribed format at the time of admission duly attested by First Class Magistrate. (Annexure IV & V). In case of candidates with Gap year, they need to submit the affidavit as prescribed in Annexure VI.

The admission process will commence from the scheduled date and the information regarding Hostel Accommodation, Hostel fee and other formalities will be facilitated at the Admission Desk (Office of Registrar Academics) of Govt Medical College Handwara (Makeshift Building) at bypass road Handwara.

The admission fee (Rs 34215/-) will be collected at the admission desk in form of DEMAND DRAFT only. Demand Draft should be made in favour of Chief Accounts Officer, Government Medical College Handwara payable at JK Bank Handwara.

No Fee to be deducted on re-allocation of seat to the candidates in 2nd /3rd Round of Counselling. Full Admission Fee to be reimbursed in case Candidate resigns during Counselling period.

Commencement of Academic Session for f<sup>\*\*</sup> Year MBBS Course in Govt. Medical College Handwara will be from 01-10-2024.
