Whereas, Government Medical College, Handwara, invited applications for the post of Medical Officer at the Addiction Treatment Facility (ATF) under the National Drug Dependence Treatment Centre (NDDTC) on a contractual basis, vide Advertisement Notice No. 03-(ATF) GMCH of 2025, dated 06-02-2025.

Whereas, the College conducted a Written MCQ-OMR Based Test for the said position on 20th March 2025, as notified vide Notification No: GMC/Hand/2025/Acad/236-38, dated 12/03/2025.

Whereas, on basis of marks obtained by all candidates in the MCQ-based (OMR) written test and in accordance with the criteria laid out in the advertisement, the candidates listed in Annexure II of the Office order No. 16 – (ATF) GMCH of 2025 Dated: 05-04-2025 were hereby provisionally shortlisted for Viva Voce for the post of Medical Officer (ATF).

Whereas, the college conducted the Viva Voce/Interview of the shortlisted candidates on 15-04-2025, the final marks obtained in the written and viva of the candidates are annexed at *Annexure I* to this notification.

Therefore, based on the marks obtained in the MCQ-based (OMR) written test and in Viva Voce/Interview and in accordance with the criteria laid out in the advertisement, Dr Owais Ahmed Mir, against an available vacancy of 01 post, is hereby provisionally selected for the post of Medical Officer (ATF).

- The selection is purely on contractual basis for a period of one year which will be extended subject to good performance and conduct of the candidate or till the continuation of centrally sponsored scheme, whichever is earlier.
- The selected candidate shall have to execute a contract agreement with the principal, GMC Handwara / Nodal Officer ATF that he or she shall not claim for any regular appointment or extension in the department.
