Subject: Selection of Senior Residents/Tutors in various departments of Govt Medical College Handwara on Academic Arrangement Basis as per S.O 364 of 2020, dated:27/11/2020.

# Office Order No. 02 - SR(GMCH) of 2025. Dated: 17-01-2025.

Whereas, the Government Medical College, Handwara, advertised vacant positions for Senior Residents and Tutors in various departments through Advertisement Notification No. 05 (SR) of 2024, Dt: 14-12-2024 and for the department of Orthopaedics vide Advertisement Notice Vide: GMC/Hand/Acad/2024/806-09, Dt: 16/12/2024 purely on an Academic Arrangement basis as per S.O. 364 of 2020, Dated: 27-11-2020.

Whereas, the selection committee assigned for scrutinizing the application forms and for conducting a written test for the given tenure positions meticulously scrutinized all submitted application forms, adhering strictly to the Criteria/Policy Guidelines for eligibility and selection to tenured positions, as specified in Government Order No. 383-JK(HME) of 2024, Dt: 20-06-2024.

Whereas, on the basis of scrutiny of the applications by the selection committee for eligibility/selection and on the basis of number of applications received and vacancies available, the written MCQs based test will be conducted for the candidates of the departments mentioned at Annexure I to this notification based on the guidelines envisaged in Govt Order No. 383-JK(HME) of 2024, Dt: 20-06-2024. (The number of candidates applying for each discipline/department were more than the number of vacancies available in the given discipline/department)

Whereas, on the basis of scrutiny of the applications by the selection committee for eligibility/selection, the candidates who had applied for the departments mentioned in *Annexure II* have been found in-eligible as per guidelines established in Govt Order No. 383-JK(HME) of 2024, Dt: 20-06-2024.

Whereas, on the basis of detailed scrutiny of the applications by the selection committee for eligibility/selection and on the basis of number of applications received and vacancies available, the written MCQs based test was dispensed for the candidates from the departments specified in Annexure III to this notification based on the guidelines set forth in Govt Order No. 383-JK(HME) of 2024, Dt: 20-06-2024. Whereas, the Written test for the selection of Senior Residents for the department of Orthopedics will be conducted as per following schedule:

- Exam Type: Multiple Choice Question (MCQ) OMR Based Test.
- Date: 24<sup>TH</sup> January 2025 (Friday)
- Venue: Makeshift Campus of GMC Handwara, Bypass Road Handwara
- Time: 10:30 AM to 12:30 PM.

The eligible candidates for the department of Orthopedics as annexed in Annexure IV of this notification are required to collect their Admit Cards from the office of Registrar Academics, Govt Medical College Handwara on 21st January 2025 (Tuesday). Candidates are must bring 01 passport size photograph along with them on the given date.

The date and time of the written MCQs based test for selection for the candidates in the departments of (Anatomy, Pathology) as mentioned in <u>Annexure I</u> will be notified separately on the official website of Govt Medical College Handwara soon.

Therefore, the candidates listed in **Annexure III** of this notification are hereby provisionally **selected** for the tenured positions in the respective departments as indicated against their names.

However, as per the advertisement and rules of engagement, the candidates are provisionally selected on academic arrangement basis initially for a period of *O1* year which can be extended to a maximum of 03 years based on performance and good conduct report by the concerned head of the department/section.

However, engagement of the selected doctors shall be subject to the following conditions:

- That the doctors shall submit their joining report, along with original documents as required at the time of submission of application forms in the advertisement notification for verification, in the office of Principal Govt Medical College Handwara within 15 days from the date of issuance of this selection order.
- 2. That they shall submit an affidavit duly attested by first class magistrate to the effect that:

- He/she is not involved in any criminal activity and there is no FIR pending against him in any Criminal Department or Police Station.
- He/she will not indulge in private practice during the tenure. In case he is found doing private practice his appointment shall be terminated without any notice.
- III. He/she shall not leave the department before the completion of his/her sanctioned tenure.
- He/she will not participate in any kind of strike during the period of his/her tenure as the services are covered under ESMA.
- V. He/she shall remain disciplined during the tenure period and any kind of misconduct shall make him/her liable for termination without any prior notice.
- First month's salary of the candidate shall remain in deposit with the Accounts Department as security and shall be paid on successful completion of their first tenure appointment of 01 year.
- 4. Candidates whose results are awaited\* at the time of selection must submit an affidavit/undertaking duly attested by first class magistrate stating that they will provide the degree and registration certificates within one month of joining. Failure to do so will result in cancellation of their candidature and their selection ab initio.
- 5. Salary will be disbursed only after the proper CID Verification of the candidates.
- No experience certificate will be issued if he/she leaves fails to serve his/her tenured position for at least 06 months.
