### OFFICE ORDER NO. 22- JR (GMCH) of 2026 Dated: 24-03-2026

**Subject:** Operationalization of Waiting List for the tenure position of Junior Residents in various Departments of Govt. Medical College Handwara on Academic Arrangement Basis under S.O 364 of 2020.

**Whereas**, the written examination (MCQ OMR-Based) was conducted on 18-11-2025 and selection was strictly on the basis of merit and availability of vacancies.

**Whereas**, Government Medical College, Handwara issued office order No. 67-JR (GMCH) of 2025, dated: 24-12-2025 regarding provisional selection of candidates for engagement as Junior Residents on academic Arrangement Basis under S.O 364 of 2020, dated 27-11-2020.

**Whereas** Govt. Medical College Handwara issued office order 19 - JR (GMCH) of 2026 dated: 11-03-2026 regarding Operationalization of waiting list for provisional selection of Candidates for engagement as junior residents on academic arrangement basis under S.O 364 of 2020: Dated 27-11-2020.

Now, therefore, in accordance and continuation with the said order, a waiting list is required to be maintained for a period of three months to meet contingencies arising out of non-joining in previous waiting list or provisionally selected candidates within the prescribed joining period.

Now therefore, the candidates listed in "**Annexure I**" (waiting list) to this order are hereby provisionally selected for engagements as Junior Residents in various Departments of Government Medical College Handwara on Academic Arrangement Basis under S.O 364 of 2020, dated 27-11-2020, strictly in order of merit, owing to the failure of joining by certain provisionally selected candidates and resignations thereafter and completion of tenure of some junior residents and shall be governed by the conditions detailed hereunder.

The engagement of the selected candidates is strictly provisional and initially for a period of six (06) months, which may be extended up to maximum of one-year

subject to performance and good conduct as reported by the concerned Head of Department/Section.

The Department allotted to the provisionally selected candidates shall be allotted strictly in accordance with the sanctioned strength of each department of Govt. Medical College Handwara. However, the said Department allotment shall remain subject to change at any stage as per Institutional requirement and Administrative exigencies after completion of joining and document verification formalities. However, engagement of the selected doctors shall be subject to the following conditions:

1. The candidates shall submit their Joining Report along with Original Documents for verification in the office of the Principal, GMC Handwara, within **(07)** days from the date of issuance of this order. Failure to join within the stipulated time shall result in cancellation of the candidature.
2. The candidates shall furnish an **affidavit duly attested by a First-Class Magistrate** declaring the following:
  - a. That he/she is not involved in any criminal activity and that no FIR is pending against him/her in any police station or criminal department.
  - b. That he/she shall not indulge in private practice during the tenure. Any violation of this condition shall result in termination of the appointment without any prior notice.
  - c. That he/she shall not resign or leave the department before the completion of the sanctioned tenure.
  - d. That he/she shall not participate in any strike or similar activities during the tenure, as the services fall under the purview of the Essential Services Maintenance Act (ESMA).
  - e. That he/she shall maintain discipline and good conduct during the tenure. Any misconduct shall render him/her liable for immediate termination without notice.
  - f. That he/she is not on the rolls of any other medical college or institution in any capacity.
3. The first month's salary of the candidate shall remain in deposit with the Accounts Section as security and shall only be released upon successful completion of the initial six-month tenure.
